**ELIGIBILITY:** Drivers must be holders of a current Speedway Australia racing license and Insurance. Drivers must have a current Formula 500s Australia Inc. Rules / Log Book - July 2017 (to be produced at the time of scrutineering).

**SCRUTINEERING:** 2.00pm - 3.30pm

**RACING TO COMMENCE:** 4.00pm

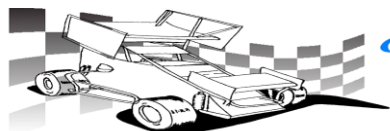

All drivers must pay at Main Gate upon entry - \$20.00

**TRACK DESCRIPTION:** 400m on Pole Line. Clay surface

**PRACTICE:** Will be permitted **ONLY** if time permits.

**GRID POSITIONS:**

- Each driver/entrant will have a varied positional grid draw of 3 Heats.
- The highest point scorer after the 3 allocated heats shall be allocated pole position on the grid in the Final.
- The positions of any cars tied on points will be determined by their fastest lap time in the heats.

**HEAT POINTS:** As per Rule 41 - page 16 - 2017 Australian Rules / Log Book.

**RACE LAPS:**

**HEATS = 8 laps.**

**'B' MAIN: = 12 laps** to be contested with a maximum of twenty (20) cars.  
(first four place-getters in the 'B' Main will qualify for the final).

**TITLE FINAL = 20 laps** to be contested with a maximum of twenty (20) cars.

**TIMING:** Transponders will be used in this Title event. Rule 41(a) - page 17.

Owner supplied transponders must be **AMB Tranx 260 Transponders**. Own supplied transponders are to be maintained by the owner and charged prior to the commencement of the meeting. Transponders are to be mounted as per Rule 19 - page 35 - 2017 Australian Formula 500 Rules / Log Book.

Transponders will be available for hire.

Lost, damaged or non-returned transponders that are hired within the Title event will incur a replacement fee.

**NOMINATION FEE:** \$ 85.00 (to be paid at time of entry – see below).

**TRANSPONDER HIRE FEE:** \$ 20.00 (to be paid at time of entry)

**LATE NOMINATION:** \$ 120.00. All late nominations will start rear of field in all heats.

**NOTE-** All late nominations *do not* include the Transponder Hire Fee.

**RACE RECEIVERS:** One way communication will be used in this Title event.

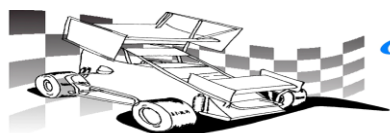

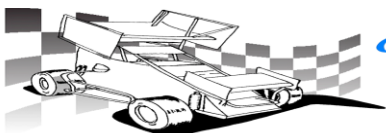

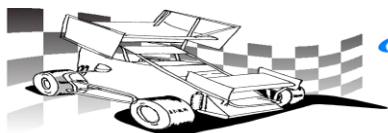
